MLS Heads-up: NAR new policy adopted at November meeting, must be in force by May

1. GAAR Rules and Regs will be revised accordingly.

"Within one business day of marketing a property to the public, the listing broker must submit the listing to the MLS for cooperation with other MLS participants. Public marketing includes, but is not limited to, flyers displayed in windows, yard signs, digital marketing on public facing websites, brokerage website displays (including IDX and VOW), digital communications marketing (email blasts), multi-brokerage listing sharing networks, and applications available to the general public."

You will be hearing more about this as the May 1 date approaches. The key words to note here are marketing a property to the public. This will include signs, social media, flyers, etc. It does not change the 72 hour rule that is in place in GAAR MLS Rules and Regs if the property is not being "marketed to the public". VAR has a video on their site by legal counsel Laura Farley that addresses the issue.
